The Annual Meeting held on 7/19 was well attended. Following are the highlights:

- CTC has officially converted to a 501 (c) (3) non-profit corporation! Because the conversion occurred before the annual meeting, the meeting was officially our first "Members" meeting under the new structure. Outstanding shares in the for-profit company have been converted to donations to the non-profit. Former stockholders can become members of the non-profit for no fee. New members will be charged a \$40 membership fee. Currently, approximately 300 people have become members of the non-profit. If you would like to become a member, notify us by providing your name, address, phone number, and email to the office along with your membership fee (if applicable). Members will receive communications from the company and be eligible to attend the annual membership meeting where they will elect the board of directors. There will be no change in our ferry fare structure except that the current "Stockholder tickets" will be renamed "10 Ride Tickets" and offered at the same price as today.
- CTC has a new auditor (our prior auditor retired). The new auditor, Adam Hobson, visited our office and reviewed our financials and our controls. The result was another good audit. Adam has many non-profit clients, so he will be very helpful as we make the necessary adjustments under our new structure.
- Members were provided an update on the Board's strategic planning efforts, the recent addition of credit card process, and our project to evaluate the long term viability of the Pied Piper.
- Amanda Campbell was congratulated for passing her exam for a 100-ton Captain's license.
- Bud Quinn and Leon Hamilton were recognized for their years of dedicated service to CTC.
- Three directors were elected: Mike Conroy, Geoff Summa, and Specs Eaton.
